Sound equipment update

Alec found the sound system papers. The sound system, bought from Grandma's Music had a 6 years warranty that expired 2 years ago. We bought 2 speakers in Sept 08 for \$725 each and two in May 09 for \$689 each and the subwoofer for \$1069. We also bought two stands. Alec will ask Doug if he knows where they are.

In former times we had money set apart for the sound system. We will look into this if we have the numbers.

One speaker didn't work last Sunday. It is often due to a problem with the cables. Jay will measure and buy one long cable that will go from entrée way to speaker.

Tracy will ask Joan for Tax exempt Nr and give it to Jay. She also will put the number in drop-box so people can take it when they buy things for ED without having to pay tax.

Sound volume

The sound baseline is 85-95. We encourage people to go to the coordinator, who will check the level and if the sound is within the guidelines will give the person earplugs.

Ana will check with welcome person how many earplugs there are left.

Ana will get 40% from the profit for organizing. (We need to announce to the community that organizers will get a percentage form the profit)
