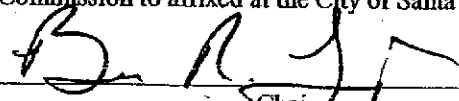
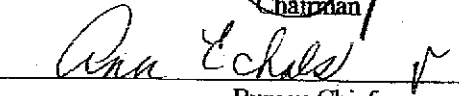

ARTICLES OF INCORPORATION

(a nonprofit corporation)

The undersigned, for the purpose of forming a nonprofit corporation pursuant to the New Mexico Nonprofit Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the nonprofit corporation is: EMBODYDANCE, INC.

ARTICLE II

Period of Duration

The period of the corporation's duration is perpetual.

ARTICLE III

Nonprofit Purposes

The corporation is formed exclusively for purposes for which a corporation may be formed under the Nonprofit Corporation Act of the State of New Mexico and shall be operated exclusively for nonprofit purposes within the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986 as amended from time to time. No part of the income of the corporation shall inure to the benefit of any

member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation effecting one or more of its purposes), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

ARTICLE IV

Purpose

The purpose for which the corporation is organized is: The purpose of Embodance, Inc. is to hold gatherings every week for sacred practice where members may, through movement, have inner experiences that encourage awareness of self and community, connection with Spirit, and inspiration in daily life.

ARTICLE V

Prohibited Activities

No substantial part of the activities of the corporation shall be devoted to carrying on propaganda, or otherwise attempting, to influence legislation, or participating in, or intervening in (including the publication or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI

Distribution on Dissolution or Liquidation

In the event of the liquidation or dissolution of the corporation, whether voluntary or involuntary, no member shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property received by the corporation from any source, after the payment of all debts and obligations of the corporation, shall be used or distributed

exclusively for purposes within those set forth in Article IV and to or through an organization described of Section 501(c) of the Internal Revenue Code of 1986 and the regulations thereunder as the same now exist or as they may be hereafter amended from time to time.

ARTICLE VII

Initial Registered Office and Agent

The address of the initial registered office of the corporation shall be 509 Camino Lejo, Santa Fe, New Mexico 87505 and the name of its initial registered agent at that address shall be Guthrie Miller.

ARTICLE VIII

Members; Directors

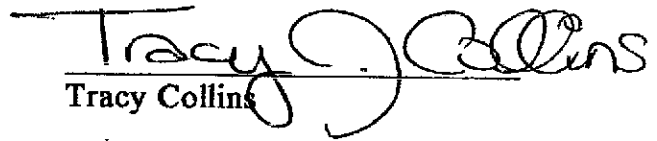

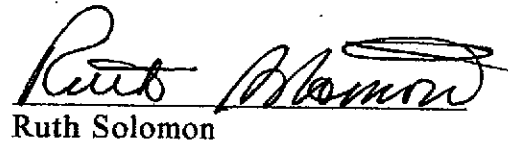
